THIS MATTER came on for consideration by the undersigned Judge of the Superior Court of Wake County. Petitioner, the North Carolina State Bar, was represented by Katherine E. Jean. Respondent, Mark Kevin Seifert, was represented by Alan M. Schneider.

Based upon the Affidavit of Surrender of Law License submitted to the court by Respondent, Mark Kevin Seifert (hereinafter "Seifert") and upon the consent of the parties, the court makes the following:

FINDINGS OF FACT

1. Seifert was licensed to practice law in North Carolina on February 25, 2000.
2. On February 3, 2014, Seifert entered a plea of guilty in Wake County Superior Court to nine felony counts of second degree sexual exploitation of a minor and judgment was entered convicting him of those offenses.

Based upon the foregoing Findings of Fact, the court makes the following:

CONCLUSIONS OF LAW

1. By pleading guilty to and being convicted of the felony offenses referred to herein, Seifert violated N.C.G.S. 84-28(b)(1) and Rule 8.4(b) of the Rules of Professional Conduct.


IT IS NOW, THEREFORE, **ORDERED**:

1. Mark Kevin Seifert is **DISBARRED** from the practice of law in North Carolina.
2. This Order of Disbarment is effective immediately.

3. Within ten days of the date of this Order, Seifert shall comply with the provisions of 27 N.C. Admin. Code, Chapter 1, Subchapter B, Section .0124 of the Rules and Regulations of the North Carolina State Bar and shall surrender his license and permanent membership card to the Secretary of the North Carolina State Bar along with the affidavit required by Section .0124(a), (b), (d) and (e).

4. The costs of this action are taxed against Seifert.





Mark Kevin Seifert, being first duly sworn, deposes and says as follows:

1. I desire to resign and hereby tender my license to practice law in North Carolina pursuant to the provisions of 27 N.C. Admin. Code Chapter 1, Subchapter B, Section .0117 of the N.C. State Bar Discipline & Disability Rules.
2. My resignation is freely and voluntarily rendered. It is not the result of coercion or duress. I am fully aware of the implications of submitting my resignation.
3. On February 3, 2014, I entered a plea of guilty in Wake County Superior Court, file nos. 2013 CRS 206061, 206062 and 206063, to nine felony counts of second degree sexual exploitation of a minor and judgment was entered convicting me of those offenses.
4. I acknowledge that the material facts upon which my guilty plea was based are true.
5. I am submitting my resignation because I know that if disciplinary charges were predicated upon my guilty plea, I could not successfully defend against them.
6. I acknowledge that I have consulted with legal counsel before submitting this affidavit.
